

RE: Review of neonicotinoid pesticides use in Canada

Attention: Pest Management Regulation Agency

I am writing to officially provide comment on the use of bee-killing neonicotinoid pesticides. I have reviewed the evidence and am persuaded that neonicotinoids are a serious threat to bees and other pollinators, and pose a serious threat to our ecosystem and food supply.

I have first contacted you on behalf of the Saskatchewan Network for Alternatives to Pesticides (SNAP) about this issue in 2006, after I was convinced by the evidence coming out of Europe.

Instead of curtailing the use of these insecticides, I have seen an ongoing increase in uses and crops they are allowed to be used on, including many insect-pollinated ones.

The evidence is well passed deliberations and the precautionary principle. Please do the right thing.

I strongly urge you to ban neonicotinoid pesticide use in Canada.

"We have a situation with neonicotinoids now which is an exact parallel with the previous situation with DDTs...where there was broad scale use over the entire landscape, and where this poison was everywhere.... It is my feeling that we're in for a kick in the back side as neonicotinoids are being spread over huge areas of farmland... Neonicotinoids could be a disaster waiting to happen.

The deadline for public comment is a fast-approaching December 12th, 2013, so 'there's no time like the present' to [send a message](#) to Health Canada's Pest Management Regulatory Agency.

We are pressing you to today because the pesticide industry lobby group "CropLife" [is in high gear](#) in their campaign to prevent a ban on the **bee-killing pesticides**. If you live in rural Ontario, you've likely seen their ads and/or planted letters/op-eds. We told you on November 15th, 2013, how they scandalously [hired](#) long-time Conservative MP Ted Menzies as CEO.

It's now or never for the bees—their future is in our hands
